Application Guideline for Semester Visiting Students

Program Objective

Global Korea Scholarship for Semester Visiting Students is designed to provide international students with opportunities to study at higher educational institutions in Korea for a semester study, which will enhance international education exchange and deepen mutual friendship between Korea and participating countries.

After rigorous evaluation process by National Institute for International Education (NIIED) under the Ministry of Education in Korea, Soonchunhyang University has been honorably selected as one of the designated universities for this scholarship program.

Scholarship Details

- Period: 2022 Fall Semester (September to December, for 4 months)
- Benefits
 - Tuition 100% covered
 - Monthly Allowance: 500,000 KRW per month
 - Settlement Allowance: 200,000 KRW (paid only once upon arrival)
 - Health Insurance covered
 - Round-trip Airfare (reimbursement within the cap amount below)
 - Students must purchase their own flight ticket and bring the original receipt with them. The reimbursement will be provided after arrival.
 - Students will be able to get reimbursement only for their actual expenses up to the cap amount as below (Note: the maximum airfares are subject to change).

Eligibility

1. Must be full-time undergraduate students from partner universities of Soonchunhyang University
2. Applicants who are currently residing in Korea, Korean citizen, or Korean dual citizenship holder are not eligible.
3. **Must possess 80% out of 100% Cumulative Grade Point Average (CGPA).**
4. **Must have completed two semesters or more at home university.**
5. Students are not allowed to apply more than one university in Korea.
6. Those who have received any scholarship from Korean government are not eligible.

Required Documents

1. Application form, Study Plan, Personal Statement (Form provided)
2. Certificate of current enrollment of home university
3. Copy of passport or birth certificate
4. Official university transcript
5. Official TOPIK or official English test score report taken within the last two years (Optional)
6. Copy of awards or other certificates (Optional)

Application Deadline: May 25, 2022

All required documents must be submitted as scanned files via email at elina@sch.ac.kr by May 25, 2022.

Important Notes

- If any of the required documents are not submitted or if any of the documents does not meet eligibility requirements, his or her application documents will be excluded from the evaluation.
- Late applications will be excluded from the evaluation.
- The university reserves the right to reject or cancel admission if applicant is found to have submitted a fraudulent/fake application to the university.

Selection Procedures

Soonchunhyang University is responsible for nominating students who meet eligibility requirements to NIIED. Then the successful candidates will be selected by NIIED.

Application Timeline

May 25, 2022	Application Deadline to Soonchunhyang University (by email)
May 26-31, 2022	Document screening by Soonchunhyang University to check applicants' eligibility
June 3, 2022	Soonchunhyang University sends applicants' documents to NIIED
End of June, 2022	NIIED informs Soonchunhyang University of successful candidates
End of June, 2022	Soonchunhyang University notifies all applicants of selection result individually

Scholarship Conditions **The details are subject to change.*

1. Students are responsible for their dormitory fee (about 815,000 KRW for one semester) and other personal expenses. The dormitory fee is due in the second week of September, 2022.
2. The scholarship period is one semester (4 months) and it cannot be extended in any circumstances.
3. Monthly allowance will be calculated based on the number of days that students stay in Korea.
4. Return ticket airfare reimbursement will be provided only in case students return to their home country within 30 days after the semester ends. The airfare reimbursement only covers the itinerary between

students' home country and Korea for study purposes. It does not cover any type of personal stop-over during the journey.

5. Scholarship recipients must take at least one regular course (2 credits or higher) on Korean language or Korean culture during his/her study in Korea.
6. Scholarship recipients are required to write two page-long essays on their study in Korea at the end of the semester.
7. If scholarship recipients commit any of the following acts or fall under any of the situations described below during their stay in Korea, their scholarship will be revoked:
 - Falsifying statements on any of their application documents;
 - Leaving Korea or not attending classes for more than one month without legitimate reasons;
 - Punishment by their respective institutions, or involvement in any form of political activities.
